# Expression of Interest information pack

Safer Care Victoria (SCV) is excited to invite health services to participate in the Check Again Breakthrough Series (BTS) Collaborative. The collaborative is a part of the 100,000 Lives program which aims to reduce harm and improve health outcomes for 100,000 Victorians over five years. #### Who is eligible to apply?

Applications are open to all Victorian hospitals that provide care to people with a penicillin allergy. We are keen to partner with health services and teams from:

- Metropolitan, rural, or regional
- Subacute or acute
- Private or public
- Adult or paediatric

At this stage, the Check Again Expert Working Group has decided to not include maternity and critically ill patients in the collaborative

#### What will the collaborative accomplish?

Check Again is an improvement collaborative that will spread and scale a penicillin allergy assessment and delabelling program for hospitalised Victorians to ensure they have access to the most appropriate and safe antibiotics. Check Again aligns with the Preventing and Controlling Infections (Standard 3) from the National Safety and Quality Health Service (NSQHS) Standards, Antimicrobial Stewardship Clinical Care Standard – Quality Statement 3.

## What does participation in the collaborative involve?

This collaborative is designed for any Victorian hospital that is committed and ready to accelerate their work in the assessment and, if appropriate, delabelling of penicillin allergies. Participation is open to all public and private health services and is free.

Participation requires the support of an executive sponsor. Health services will need to commit dedicated time and resources to the collaborative to achieve optimal results and within the project work collaboratively to:

- Complete a health service charter, setting aims and goals for the project team
- Hold weekly team meetings
- Test changes using rapid Plan-Do-Study-Act cycles
- Collect data and plot results over time
- Complete and share reports for monthly calls (virtual) and Learning Sessions (in-person)
- Contribute to monthly collaborative online meetings and site visits

Applications close at 11:59pm Thursday 25 August 2022. We recommend the application is completed by the project lead with the executive sponsor.

- Step 3 Complete the online expression of interest form here.

An optional Kickstart call (virtual meeting) will be held for all participating teams on Tuesday 6 September 2022 12:30-2pm via Microsoft Teams.
